

# Privacy Policy

We value your privacy. This policy explains each of our privacy practices for Collective Harvest as well as the services provided by Collective Harvest. By visiting this website, you are implying the acceptance of the terms of this Privacy Policy. We are not responsible for the content or the privacy policies of other websites linked to on our site.

## **Information We Gather or Receive**

Collective Harvest will not sell or disclose your name, email address or any other personal information to third parties without your explicit consent, except as specified in this policy.

Collective Harvest may require additional information, such as billing and payment information (including billing address, telephone number, credit card information), a telephone number, and/or a physical address. Credit card information on an account may be stored and used for billing purposes.

Collective Harvest automatically receives and records some information from your browser when you visit the site, such as your IP address, cookies and data about which pages you visit on the site through the use of log files provided by our third-party tracking-utility partners. This information helps us analyze and understand how the site works for customers and visitors, and to provide a more personalized experience for members and visitors.

Collective Harvest may receive or collect information (for example: email address) about a person who is not yet a registered Collective Harvest customer in connection with certain Collective Harvest features, including but not limited to: a non-customer showing interest or subscribing to a Collective Harvest newsletter or a non-customer requesting Collective Harvest near them.

Collective Harvest uses the information described in this policy to provide and improve our services, for billing and payments, for identification and authentication purposes, to contact members or interested parties, and for general research, analysis, and aggregate reporting.

Collective Harvest's Terms of Use require all account owners to be at least 18 years of age (or have the permission and supervision of a responsible parent or legal guardian), therefore, this policy does not discuss use of our site or services by minors and does not imply such use occur by a minor.

## **Controlling Your Information**

We want you to have control over your own information, so Collective Harvest gives you the choice of providing, editing or removing certain information.

You may correct or edit your Collective Harvest account information at any time, such as your email address, phone number or credit card information.

For various reasons, Collective Harvest may contact you about our services or your activity. Some of these messages are required, transaction-related messages to customers. Other messages are not required, such as our newsletters, and you can control which optional messages you choose to receive by changing the settings in your account.

## **Messages from Collective Harvest**

In order to fulfill orders and keep you informed, Collective Harvest will contact you. Our standard way of communication will be messages that are delivered by email and text messaging, and every account is required to keep a valid email address and phone number on file to receive messages. In some situations, Collective Harvest may contact you by telephone or physical mail in order to provide you with information about products and features you may find of interest or to provide you with more individualized customer support. You may update your contact preferences in your account settings as well.

Some messages from Collective Harvest are service-related and required for customers. Examples of service-related messages include, but are not limited to: a welcome/confirmation email when you register your account, confirmation of your order, or correspondence with the Collective Harvest support team. These messages are not promotional in nature. You may not opt-out of receiving

service-related messages from Collective Harvest, unless you close your account. If you have a question about how to close your account, please let us know at:

As a customer, Collective Harvest may also send you messages related to certain features on the site or based on your activity. Collective Harvest may also send you news or updates about changes to our site, services, or other offerings. By default, customers will receive these messages via email, but you may choose to opt-out of getting certain emails under your account settings.

Collective Harvest offers optional email newsletters as well. When you register for an account, or choose to subscribe, you will receive newsletters from us. Newsletters are available to both customers and non-customers. Customers may subscribe or unsubscribe from optional newsletters under your account settings or by following the instructions contained in the newsletter emails. Non-customers may subscribe by providing an email address. Non-customers may also unsubscribe from newsletters by following the instructions contained in the newsletter emails.

## **What Information We Share**

Collective Harvest will never sell or disclose your name, email address or other personal information to third parties without your explicit consent, except as specified in this policy.

As part of shopping from producers on our website, Collective Harvest may also facilitate the sharing of information between the two members involved in the transaction. As part of the buying process, the producers you purchase from may receive your name, email address, and phone number, and/or other information, such as order date, to assist in fulfilling your order correctly and timely.

Collective Harvest may release your personal information to a third-party in order to comply with a subpoena or other legal requirement, or when we believe in good faith that such disclosure is necessary to comply with the law; prevent imminent physical harm or financial loss; or investigate or take action regarding illegal activities, suspected fraud, or violations of Collective Harvest's Terms of Use. We may disclose personally identifiable information to parties in

compliance with our Copyright Policy, as we in our sole discretion believe it to be necessary or appropriate in connection with an investigation of fraud, intellectual property infringement, piracy, or other unlawful activity. In such events, Collective Harvest may disclose name, address, country, phone number, email address and company name.

Collective Harvest uses other companies and people to perform tasks on our behalf, and we need to share your information with them to provide products and services to you. Examples include but are not limited to fulfilling orders, processing payments, handling billing disputes and collections, analyzing data, providing marketing assistance and providing customer service.

In some cases, Collective Harvest may choose to buy or sell assets. In these types of transactions, member information is typically one of the business assets that is transferred. Collective Harvest will transfer information about you if Collective Harvest is acquired by or merged with another company. In this event, Collective Harvest will notify you by email or by putting a prominent notice on the site before information about you is transferred and becomes subject to a different privacy policy.

When you load a page on Collective Harvest that has a social plug-in from a third-party site or service, such as a Facebook, Twitter, or Instagram hyperlink, you are also loading content from that third-party site. We can only speak for ourselves; this policy does not apply to the practices of third parties that Collective Harvest does not own or control, or individuals that Collective Harvest does not employ or manage. If you provide your information to others on Collective Harvest or throughout the Internet, different rules may apply to the use or disclosure of the information you provide to them. Collective Harvest does not control the privacy policies of third parties, and you are subject to the privacy policies of those third parties where applicable. Collective Harvest is not responsible for the privacy or security practices of other websites on the Internet, even those linked to or from the Collective Harvest site. We strongly encourage you to ask questions before you disclose your personal information to others.

We reserve the right to transfer information (including your personal data) to a third party in the event of a sale, merger, liquidation, receivership or transfer of all or substantially all of the assets of our company provided that the third party agrees to adhere to the terms of our Privacy Policy and provided that the third party only uses your personal data for the purposes that you provided it to us. You will be notified in the event of any such transfer and you will be afforded an opportunity to opt-out.

## **Cookies & Tracking Technologies**

Collective Harvest leverages technologies to help us better understand how people use our site and services. Collective Harvest may partner with third-party services who may use various tracking technologies, such as browser cookies or Flash cookies, to provide certain services or features. These technologies allow a partner to recognize your computer each time you visit Collective Harvest, but do not allow access to personally identifiable information from Collective Harvest. Collective Harvest does not have access or control over these third-party technologies, and they are not covered by our privacy statement.

## **Data Retention**

Collective Harvest will retain your information only for as long as is necessary or your account is active or as needed to provide you services. If you no longer want Collective Harvest to use your information to provide you services, you may close your account. Collective Harvest will retain and use your information as necessary to improve your experience with our products and services, comply with law enforcement and resolve disputes.

You may inform us of any changes or requests in regards to your personal data, and in accordance with our obligations under local data protection law, we may update or delete your personal data accordingly.
